1 The demurrer of Defendant craigslist, Inc. ("craigslist") came on regularly for hearing in
2 Department 302 of this Court, the Honorable Loretta M. Giorgi presiding, on August 24, 2011.
3 Having reviewed and considered the parties' briefs, supporting papers, and oral argument, and the
4 pleadings and documents on file in this matter, and good cause appearing:

5 **IT IS HEREBY ORDERED** that craigslist's demurrer is sustained as to the first (and
6 only) cause of action in the Complaint without leave to amend. California Civil Code section
7 1747.08 on its face does not apply to online transactions. Further, the applicable case law,
8 legislative intent and public policy indicate that such transactions are not, and should not be,
9 encompassed by Section 1747.08.
